What is Product Stewardship?

Product stewardship is a policy that ensures that all those involved in the lifecycle of a product share responsibility for reducing its health and environmental impacts, with producers bearing primary financial responsibility.

What is Extended Producer Responsibility (EPR)?

Extended Producer Responsibility (EPR), a central tenet of product stewardship, is a policy approach in which the producer's responsibility for their product extends to the post-consumer management of that product and its packaging.



How Does Product Stewardship Work?

- Manufacturers / producers / first importers take financial or physical responsibility for the product at the end of life
 - Establish and pay for collection programs
 - Ensure reuse, recycling or proper disposal of products
- Government provides oversight and ensures accountability
- Retailers can also provide collection / take back
- Consumers participate in collection programs




Benefits of Product Stewardship

- Responsibility on party with greatest influence over product design—Producer internalizes end-of-life management costs into price of product
- Incentive for less wasteful, less toxic, easily recoverable products
- Shifts costs from taxpayer-local government to producer-consumer
- Relieves "unfunded mandate" on local governments




Per Capita Waste Production



New York Electronics Waste Law—April 1, 2011









NY State Electronic Waste Law Fact Sheet

New York's "Electronic Equipment Recycling and Reuse Act" was passed on May 28, 2010, to become the Nation's 23rd electronic waste product stewardship law, and one of the most progressive. On April 1, 2011, manufacturers are required to have programs in place to collect their used electronics from consumers across the state. Registrations are due at the NY DEC no later than January 1, 2011.

The New York State E-Waste Law:

- Creates a statewide, manufacturersponsored recycling program for a broad range of electronic products
- Uses a market-based approach, allowing manufacturers to establish efficient, costeffective collection, reuse and recycling of electronic waste
- Sets a statewide e-waste recycling goal
- Creates incentives for surpassing the goal
- Sets basic operating requirements for recyclers, collectors and consolidators
- Relieves local governments from the financial burden of e-waste handling
- Zero fee to consumers upon acceptance of their covered electronic equipment

Manufacturers must:

- Provide reasonably convenient collection
- Accept their own brand
- Accept one item of the same type for every one they sell
- Recycle their share of the statewide recycling goal

Covers:

· Desktop and laptop computers and peripherals (monitors, keyboards, printers, scanners, fax machines); small scale

servers; televisions; small electronic equipment (VCRs, DVD players, portable digital music players, game consoles). [For a complete list, please see: www.dec.nv.gov/chemical/65583.html]

Acceptance methods:

- Mail or ship back
- Community collection events
- Fixed acceptance sites
- · Agreements with local governments or others; or any combination of above
- At least one acceptance method reasonably convenient to consumers for each county, and each municipality with a population of 10,000 or more



RESOLUTION NO. 622-09: SUPPORT EXTENDED PRODUCER RESPONSIBILITY LEGISLATION

Mr. Spickerman presented the following:

WHEREAS, according to the U.S. Environmental Protection Agency, manufactured goods and packaging constitute approximately 75 percent of materials managed by solid waste facilities in the United States, with related disposal costs being borne by residents and localities that manage solid waste; and

WHEREAS, costs for continued management of hazardous materials and products that are difficult to recycle are expected to continue to rise; and

WHEREAS, neither public nor private solid waste managers have input into the design and/or marketing of these products, nor do they benefit from their sale; and

WHEREAS, a movement in the direction of Extended Producer Responsibility has began in New York State to excourage manufacturers to take responsibility for management of post-consumer products by incorporating the cost of secycling and disposal in product prices, as well as to encourage design and manufacture of products that are less toxic, more durable and easier to repair and recycle; and

WHEREAS, the New York State Association for Solid Waste Management has formed the New York Product. Stewardship Council to assist in formulating state legislation to enact Extended Producer Responsibility legislation; now, therefore, be it.

RESOLVED, that the Wayne County Board of Supervisors hereby supports Extended Producer Responsibility legislation and urges the Governor and the State Legislature to adopt said legislation; and be it further

RESOLVED, that certified copies of this resolution shall be delivered to Governor David Paterson, Senator-Michael Nazzolio, Assemblyman Robert Oaks, the New York State Association of Counties and the New York State Association for Solid Waste Management.

Mrs. Bender moved the adoption of the resolution. Seconded by Mr. Hansmond. Upon roll call, adopted.
