# PERSONAL SECURITY

---

- ✗ Power of Authority
- ✗ Emergency buttons/alarms
- ✗ Entrance/Exit from offices
- ✗ Emergency Exit plan
- ✗ Communications plan
- ✗ Medical treatment plan
- ✗ YOU ARE THE IMMEDIATE RESPONDER

# PHYSICAL SECURITY

---

- ✖ Posted municipal building rules/regulations ordered by legislative body/local law
- ✖ Screening of customers
- ✖ Controlled access of customers
- ✖ Communication - de-escalation skills
- ✖ Removal of disorderly persons

# COMMUNICATION – DE-ESCALATION SKILLS

- ✗ YOU ARE IN CHARGE OF HOW YOU REACT
- ✗ Obtain the name of the person with who you are speaking
- ✗ Use Active Listening
- ✗ Slow down and suspend judgement
- ✗ Get them to say yes
- ✗ Don't use clichés
- ✗ Show empathy
- ✗ Consistency in Courtesy



# REMOVAL OF DISORDERLY PERSONS

## NYS PENAL LAW TRESPASS

- ✘ A person who, regardless of his intent, enters or remains in or upon premises which are at the time open to the public does so with license and privilege unless he defies a lawful order not to enter or remain, personally communicated to him by the owner of such premises or other authorized person.
- ✘ A license or privilege to enter or remain in a building which is only partly open to the public is not a license or privilege to enter or remain in that part of the building which is not open to the public.

# REMOVAL OF DISORDERLY PERSONS

## NYS PENAL LAW TRESPASS

- ✗ § 140.05. Trespass.
- ✗ A person is guilty of trespass when he knowingly enters or remains unlawfully in or upon premises. Trespass is a violation.



# REMOVAL OF DISORDERLY PERSONS

## NYS PENAL LAW DISORDERLY CONDUCT

- ✗ § 240.20 Disorderly conduct.
- ✗ A person is guilty of disorderly conduct when, with intent to cause public inconvenience, annoyance or alarm, or recklessly creating a risk thereof:
  - ✗ 1. He engages in fighting or in violent, tumultuous or threatening behavior; or
  - ✗ 2. He makes unreasonable noise; or
  - ✗ 3. In a public place, he uses abusive or obscene language, or makes an obscene gesture; or
  - ✗ 4. Without lawful authority, he disturbs any lawful assembly or meeting of persons;
- ✗ Disorderly conduct is a violation.



# ENVIRONMENTAL SECURITY

---

## ✖ Lighting

- + Emergency lighting
- + Exit/entrance lighting
- + Parking lot lighting
- + Corridor lighting

# ENVIRONMENTAL SECURITY

---

- ✖ Access Control:
  - + Access to building
  - + Access to offices
  - + Primary Exits
  - + Secondary exits

# ENVIRONMENTAL SECURITY

## ✕ Exit Plan

- + Establish a plan
- + Physical barrier to attacker
- + Emergency communications
- + Improvised weapons
- + Exit from safe area
- + All clear



# ENVIRONMENTAL SECURITY

## ✕ Run, Hide or Fight

- + Determine type of threat
- + Run from threat
- + Hide and wait for help
- + Fight with any weapons available
- + Know your surroundings
- + Cover and Concealment
- + Position of advantage
- + Act first with overwhelming violence

# ENVIRONMENTAL SECURITY

- ✖ OODA Loop
- ✖ Col. Boyd
- ✖ Korean War fighter pilot
- ✖ The person who can Observe, Orient, Decide and Act first controls the conflict
- ✖ Disrupt the attacker's plans and actions by any means available
- ✖ Target vulnerable areas of the body

# ENVIRONMENTAL SECURITY

---

- ✕ Emergency medical training
- ✕ Hands free CPR
- ✕ AED
- ✕ Medical trauma kit
  - + Tourniquet
  - + Quick clot bandage
  - + Pneumothorax covering



# SECURITY PERSONNEL

- ✕ Police Officer
- ✕ Constable
- ✕ Bailiff
- ✕ Security Guard
- ✕ Armed Security Guard

# MUNICIPAL SECURITY

---

- ✖ Police Officer
  - + If municipality has police department
- ✖ Peace Officer:
  - + Constable
  - + Local law to establish
  - + Send to DCJS Legal Dept for review
  - + Establishment of constabulary
