Citizens Reorganization and Empowerment Grant (CREG)



CREG (Non-CFA program)

Implement General Municipal Law Article 17-A

- Re-Organization Study/Plan
- Expedited Re-Organization Assistance
- Re-Organization Implementation

CREG (Non-CFA program)

- Non-Competitive
- Monthly Deadline
- \$100,000 Maximum
 - \$50,000 maximum for a study
 - \$25,000 in expedited funds for petitioned local governments
 - \$50,000 maximum for implementation

LGE

Eligible Applicants

- Towns, villages, cities, counties,
- School districts, BOCES and certain libraries
- Special districts, fire districts

Eligible Expenses

- Contractual
- Capital, Construction and Equipment
- Transitional Personnel

LGE

Planning

- \$12,500 per municipality
- Maximum of \$100,000
- 50% State Funds/50% Local Fund

Implementation

- \$200,000 per municipality
- Maximum of \$1,000,000
- 90% State Funds/10% Local Fund

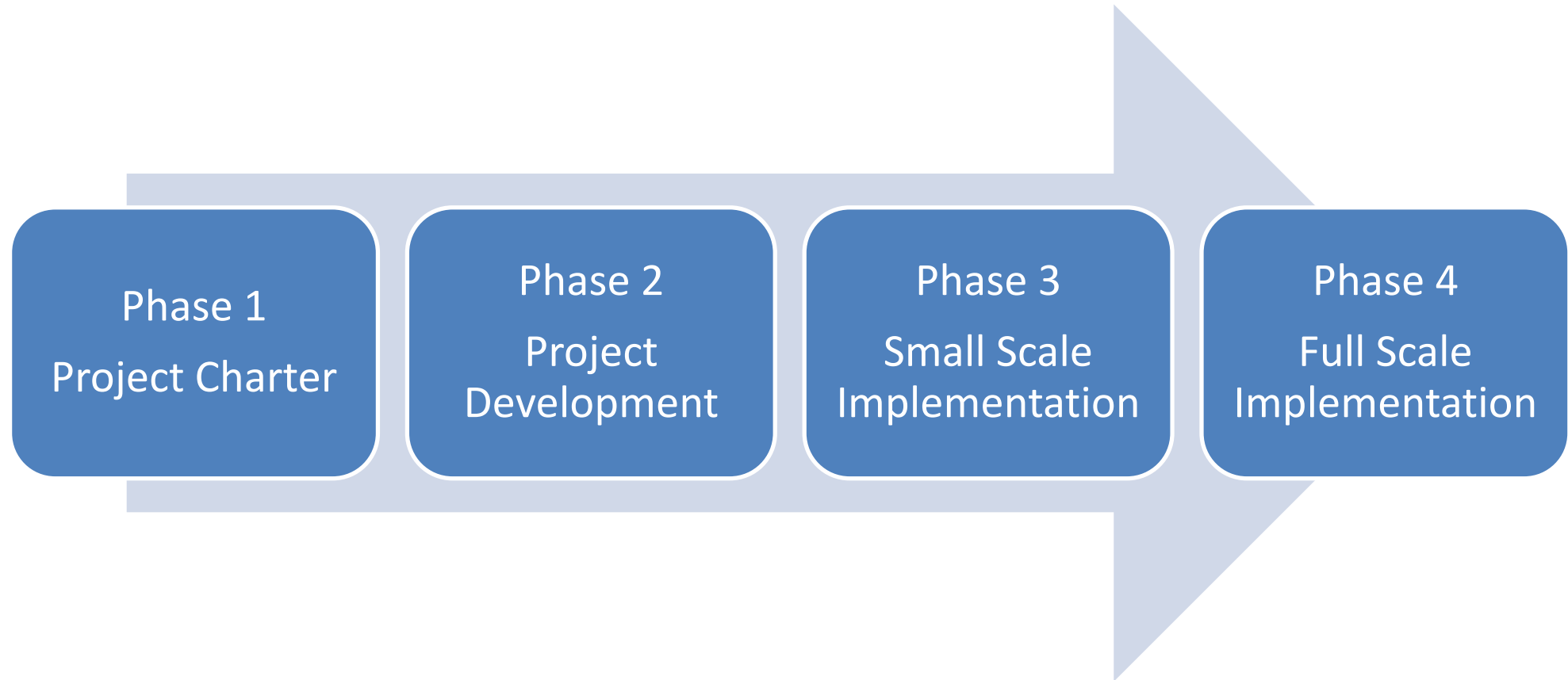
- Continuous recruitment process

- Project Roll Up Dates: 2nd Wednesdays of March, July and November

Multi-phase Approach

- 4 Phases of project development
- Approval by DOS to move between each phase
- DOS will participate at each Phase to provide
- Projects may enter at appropriate phase



MRF Phases



Phases of Funding

Phase of Funding	Maximum Amount for a Project is based on the Tax Levy Impact and Implementation Award Calculation Worksheet (not to exceed Project Cost)
1. Project Charter	Upon completion of the Project Charter: 5% of the possible award amount (up to \$50,000) for Project Development (Phase 2)
2. Project Development	Upon completion of Phase 2: Up to 35% of the possible award amount for Small Scale Implementation (Phase 3)
3. Small Scale Implementation	Upon completion of Phase 3: Up to 60% of the possible award amount for Full Scale Implementation (Phase 4)
4. Full Scale Implementation	
Total	100%

Goal 1: Economic Opportunities

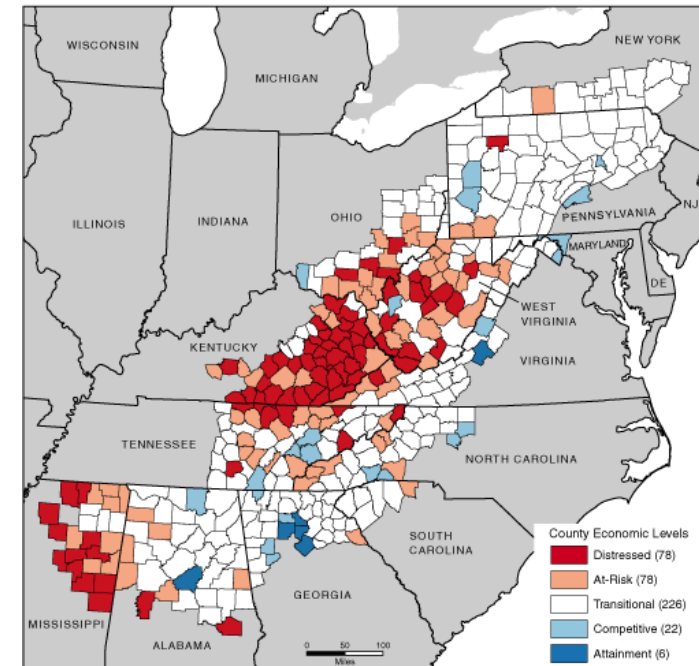
- Invest in entrepreneurial and business development strategies that strengthen Appalachia's economy.

- Invest in critical infrastructure—especially broadband; transportation, and water/wastewater systems.



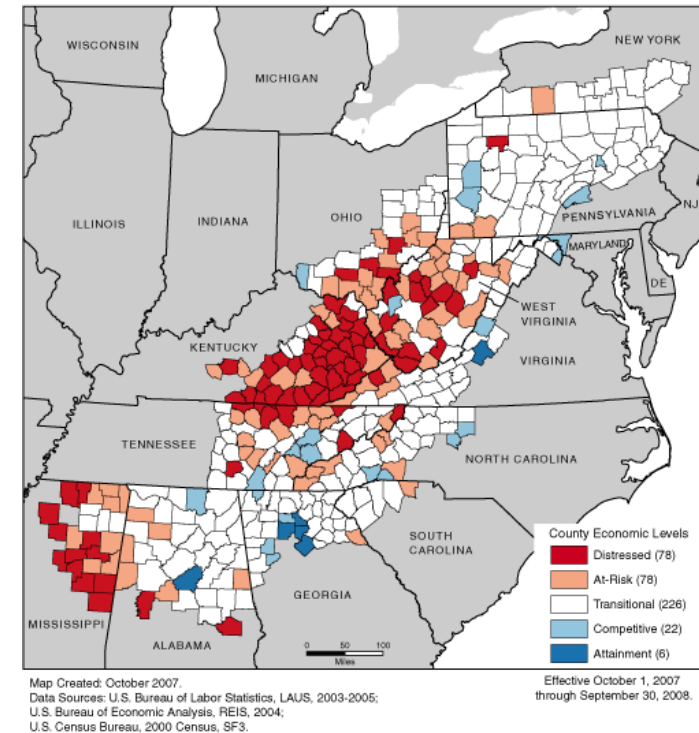

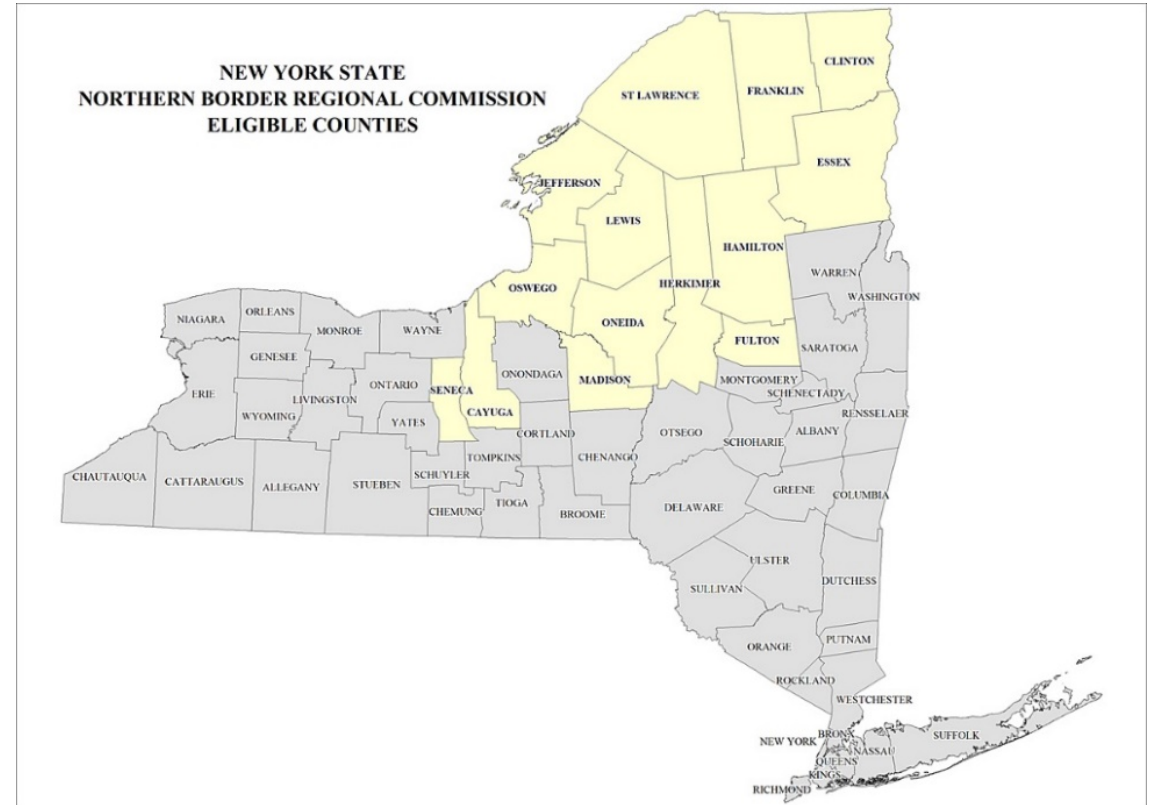
